In consideration of being permitted to observe, engage, and participate in shooting and other firearm related activities (Activities), Releasor, for himself, his spouse, legal representatives, heirs, and assigns, releases and discharges South Eastern Idaho Practical Shooters, Inc., an Idaho Corporation, it's officers, directors, members, agents, employees, and all other persons, herein after referred to as Releasees, from all liability to Releasor, his spouse, legal representatives, heirs, and assigns, for all loss or damage, and all claims or damages resulting there from, because of injury to Releasors person or property, including injury resulting in Releasor's death, whether caused by negligence of Releasees, or otherwise, while Releasor is participating in, watching, or otherwise involved in any manner with Activities. Releasor acknowledges that Activities are very dangerous and involve very substantial risk of serious injury, death, or property damage. Despite being aware of these risks, Releasor desires to enter into this Agreement. If Releasor is a minor, I sign hereon as his/her parent or legal guardian; and I represent that I have the legal authority to sign this document on behalf of such minor Releasor; and this Release shall be deemed to be of the same effect as if Releasor were a competent adult and had signed in his own behalf. Releasor agrees to indemnify Releasees from any loss, liability, damage, or cost of whatever kind that Releasees may incur because of the presence of Releasor, or any of Releasor's guests or invitees, upon any property (Property) owned, operated, managed, controlled in any way by any of Releasees, whether caused by negligence of Releasee or otherwise. Releasor hereby assumes full responsibility for risk or bodily injury, death, or property damage because of negligence of Releasees, or otherwise, while in or upon Property or while Releasor is participating in, watching, or otherwise involved in any manner with any of Activities. Releasor agrees and requests that this Release, Waiver, and Indemnity Agreement is intended to be as broad and inclusive as permitted by the law of the State of Idaho, and if any portion hereof is invalid, that the balance shall, nevertheless, continue in full force and legal effect.
